HALWAY HOUSE STAFF RECEIVE FULL TRAINING TO ENSURE COMPLIANCE WITH STATUTORY OBLIGATIONS AND BEST PRACTICE HALFWAY HOUSE BUILDING IS SECURE AND FITTED WITH METAL SHUTTERS MINIMAL STOCK IS KEPT WITHIN THE BUILDING. THE HALWAY HOUSE IS NOT LEFT UNATTENDED WHILST OPEN CUSTOMERS TO THE HALFWAY HOUSE ARE GOLFERS WHO ARE LISTED ON OUR TEE SHEET, OR THEIR CADDIES WHOM WE HAVE SUPPLIED.

b) The prevention of crime and disorder

BUILDING SECURITY IS PRIORITISED WITH HEAVY DEADLOCKED DOOR AND METAL SHUTTERS. NO LIVERY OR SIGNAGE IS DISPLAYED ON THE BUILDING EXTERIOR SO BUILDING IS NOT EASILY IDENTIFIED AS A RETAIL PREMISES. ONLY VERY SMALL AMOUNT OF STOCK IS LEFT I THE BUILDING OVERNIGHT AS HALFWAY HOUSE IS STOCKED DAILY FROM THE MAIN CLUBHOUSE STORE.

ONLY A LIMITED NUMBER OF DRINKS WILL BE SOLD TO ANY INDIVIDUAL/GROUP AS IT MUST NOT UNDULY DELAY THE PLAYING OF GOLF. NO MUSIC WILL BE PLAYED. ALL EXCESSIVE NOISES ARE CONTRARY TO THE PLAYING OF GOLF HAPPENING NEARBY.

e) The protection of children from harm

WE MAINTAIN A DATABASE OF OUR CUSTOMERS SO TEND TO KNOW WHO ARE UNDERAGE FOR ALL MEMBERS AND VISITORS HOWEVER WHERE WE ARE UNCERTAIN FOR ANY REASON, AN AGE VERIFICATION POLICY TO BE USED WHEREBY THOSE WHO APPEAR TO BE UNDER THE AGE 25 ARE ASKED TO PRODUCE IDENTIFICATION BEARING THE PHOTOGRAPH AND DATE OF BIRTH ALONG WITH A HOLOGRAPHIC MARK AND/OR ULTRAVIOLET FEATURE.
