

ANTI-SOCIAL BEHAVIOUR, CRIME AND POLICING ACT 2014 (ABCPA 2014)

EXTENSION OF PUBLIC SPACES PROTECTION ORDER

Made by: FYLDE BOROUGH COUNCIL (the Council)

- A. This order further extends a public spaces protection order made by the Council on 28 June 2019 ('the Original Order') and previously extended by an order dated 1 June 2022.
- B. This is the extension made by this order:

The Original Order is extended for a further three years and applies until 30 June 2028.

- C. The further extension made by this order comes into effect the day following the date when this order was made.
- D. The text of the Original Order as further extended is shown below:

PUBLIC SPACES PROTECTION ORDER

Made by: FYLDE BOROUGH COUNCIL (the Council)

1. THE ORDER

This is a public spaces protection order made by the Council under section 59 of ABCPA 2014.

WHERE DOES THIS ORDER APPLY?

This order applies to the land shown edged in red on the plan attached to this order, which is the **beach and sand dunes** at Lytham St Annes to the mean low water mark between a line extending seaward from the southernmost point of the housing development accessed from Fletcher Drive, St Annes and a line extending seaward from Jubilee House, Lytham.

WHEN DOES THIS ORDER APPLY?

This order applies until 30 June 2028.

4. WHO DOES THIS ORDER APPLY TO?

This order applies to any person.

5. WHAT DOES THIS ORDER REQUIRE?

This order requires a person to **not light or cook on any barbecue** in the area where the order applies.

It also requires a person to **not bring any barbecue into the area** where the order applies with the intention of lighting it or cooking on it there, knowing that doing so is prohibited.

"Barbecue" includes any outdoor temporary cooking facility or equipment.

6. ARE THERE ANY EXCEPTIONS?

The requirement in paragraph 5 above does not apply if the Council has given written permission to use a barbecue at a particular time and place, and the barbecue is used at that time and place and in compliance with any conditions attached to that permission.

WHAT CAN HAPPEN IF I BREACH THIS ORDER?


You can be given a **fixed penalty** notice of £50. Or **you could be prosecuted** in the magistrates' court for a criminal offence and be fined up to £1,000.
