

## EXPRESSION OF INTEREST FOR LAND AT ST PAUL'S AVENUE CAR PARK

### **LICENCE FOR USE:**

# Retail Sales of Ices, Sweets, and Cold Snacks (excluding Cakes) and Hot and Cold Drinks Only

- At the junction of St Paul's Avenue Car Park and Inner Promenade, Lytham St Anne's, FY8 1EQ
- Attractive Prominent Location with high footfall
- Adjacent to Fairhaven Lakes
- At the entrance of St Paul's Avenue Car Park
- Approximately 16m x 3m (52' x 9')







#### Location

Prominently positioned fronting Inner Promenade, at the entrance to St Paul's Avenue Car Park, the site is adjacent to the highly popular Fairhaven Lake and Gardens which is a year round destination offering a variety of leisure activities and events, including water-based recreation on the lake itself.

#### **Description**

The site shown in red (for identification purposes only) comprises a concrete surface extending to approximately 48 square metres (516 square feet).

There is no direct power supply to the site. The appointed operator will be responsible for providing their own portable power source (e.g. portable generator, retail sales vehicle, etc.).

#### **Parking**

Fylde Council Public car parks are available nearby along with unrestricted free parking on the main Inner Promenade.

#### Use

The site is being offered for use as: Retail Sales of Ices, Sweets, Cold Snacks (excluding Cakes), Hot and Cold Drinks Only.

No other use will be permitted.

No physical structures will be permitted

#### **Expressions of interest (EOI)**

Fylde Council invites expressions of interest from prospective operators, which should ideally address the following points.

#### Proposed Use

- A detailed description of your proposed use (e.g. type of goods/services to be sold, nature of trading activity).
- Details of any vehicle and / or trailer etc. to be placed on the site (including dimensions and photographs if available).

- Anticipated seasonal use (e.g. year-round or summer-only).

#### Power and Utilities

• Confirmation of how power will be supplied (e.g. self-contained generator, vehicle power supply, etc.).

#### Experience and Operation

- Brief details of relevant trading experience or similar operations previously run.
- Any relevant permits, licences, or food hygiene registration (if applicable).
- Details of proposed waste management and litter control arrangement, to ensure there is no adverse impact on the surrounding area or neighbouring vicinity.

#### Financial Proposal

- Proposed annual Licence Fee (rent) offered by applicant.
- Any additional value or benefit to the local area/community (e.g. local employment, complementary use to Fairhaven Lakes etc.).

• Full contact information (name, business name, address, telephone, email).

#### **Tenure & Terms**

The term of any proposal will be subject to negotiation but it would be Fylde Council's intention to offer a short term Licence Agreement.

#### Viewing

The land is wholly owned by Fylde Council and can be readily viewed from the roadside. No appointment or access arrangements are required.
